**NOTICE:** From and after 9 months of a license period, the license fee for new establishments or operators shall be one-half of the appropriate annual license fee plus any penalty that may be required. Establishment license fees are not transferrable from person or place. License fees are not refundable.

**PENALTY FEE:** A penalty fee of 25% of the annual license fee is required when applying less than 10 days prior to opening any establishment.
